I am to refer to your 02 online RTI applications dated 19/05/2020 and 20/05/2020 bearing registration No. DOHRE/R/T/20/00063 and DOHRE/R/T/20/00067, which have been received in this Department on transfer from Department of Health & Family Welfare, MOHFW, vide registration No. MOHFW/R/E/20/01385 and Ministry of AYUSH vide registration No.AYUSH/R/E/20/00299, respectively.

- In so far as this Department is concerned, electrohomeopathy is not a recognised system of medicine, at present. A proposal seeking recognition of the system, is still under consideration by an Inter-Departmental Committee, constituted by this Department. However, there is no bar on practicing in electropathy or imparting education as long as this is done within the provision of this Ministry's Order No. R.14015/25/96-U & H (R) (Pt.) dated 25/11/2003 (copy enclosed).

This Council cannot ban or stop the institutions or college which are giving educations regarding alternative system of Medicines like Electropathy or Electro homeopathy and their practice provided they should not practice Allopathic Medicine.



SEFORE THE APPELLATE AUTHORITY, MINISTRY OF HEALTH & FAMILY WELFARE, UNDER RTI ACT, 2005.

#### ORDER

This is regarding an appeal dated 15.07.2011 received on 22.07.2011 in Hospital Division preferred by Dr. Ashok Kumar against the reply given by the CPIO vide Ministry's letter DyNO. 201/RTI/2011-H dated 23.06.2011 to his RTI application. dated 25.05.2011

The CPIO in his reply has informed him that as per Section 2(h) of the Clinical Establishments (Registration & Regulation) Act, 2010, "recognized system of medicine" means Allopathy, Yoga, Naturopathy, Ayuryeda, Homocopathy, Siddha and Unani Systems of medicine or any other system of medicine as may be recognized by the Central Government. Since Electropathy has not yet been recognized by Government of India vide Deptt, of Health Resarch's Order No. V 25011/276/2009-HR dated 05.05.2010, it is not covered under the Chinical Establishments(Registration & Regulation) Act 2010. The order dated 5.05.2010 is self-explanatory.

It is found that the CPIO has already supplied the requisite information on the subject correctly. The applicant has now sought an opinion vide his appeal as to why electropathy, should not be banned in the country since it is not covered under the Clinical Establishments (Registration & Regulation) Act. 2010.

I find this question seeking an opinion, beyond the purview of the RH Act, 2008.

In view of above, the appeal is disposed of accordingly.

Appeal, if any, against this order may be preferred before the Central Information Commission (CIC) within ninety days of receipt of this order.

With reference to your RTI application dated 15.12.2010 transferred from President's Secretariat vide their letter No. 1590/RTI/12/10-11 dated 28.01.2011 received in this Section on 09.02.2011, I am to inform you that as per Section 2(c)(i) and 2(h) of the Clinical Establishments(Registration & Regulation) Act, 2010, all recognized systems of medicine i.e., Allopathy, Yoga, Naturopathy, Ayurveda, Homoeopathy, Siddha and Unani system of medicines or any other system of medicine as may be recognized by the Central Government, will be allowed for registration. On the issue of recognition of Electro-homoeopathy as recognized system of medicine, this Ministry has issued an order vide File No. V.25011/276/2009-HR dated 05.05.2010 stating that Electro-homoeopathy is not yet recognized as a system of medicine. However, there is no bar on practicing electro-homoeopathy or imparting education (Copy enclosed),
